1. Call to Order

- 2. Consider Board Approval for MDOT Mandated Repair of Sewer Force Main Casing Located at Highway 57 / Interstate 10 On Ramp, Exhibit "A" Mr. Page presented this item. Staff requests approval to proceed with Emergency Repairs, Not to Exceed \$100,000.00, to address voids that have formed along the 30" Force Main cased crossing under the westbound onramp of I-10 at Hwy. 57. The repair will address issues with voids that could form in addition to providing a more permanent repair of the roadway in accordance to MDOT standards. Following questions, comments and discussion, Director Eldridge made a motion to Approve MDOT Mandated Repairs as presented, NTE \$100,000.00. Director Moore seconded the motion. Director Munro asked if there were any other questions or comments, there were none. Motion carried with a unanimous vote by the Board Members present.
